Stipulations

- b) Tuition fees in excess of awarded OSAP may be paid using a modified Payment Plan B, which must be calculated by the Cashiers before the deferment application can be accepted.
- Students under 18 years must have a Guarantor sign the Promissory Note. In this case, the student should not sign the Promissory Note themselves.
